



Terms & Conditions

Payment Terms:

- 1.1. The Client shall make payment for the web development services as per the agreed-upon payment schedule and terms outlined in the project proposal or agreement.
- 1.2. All payments shall be made in the currency specified by the RR Web Development.
- 1.3. The RR Web Development reserves the right to modify the payment terms and schedule upon mutual agreement with the Client.

Payment Methods:

- 2.1. The RR Web Development accepts payments through the following methods: bank transfer, credit/debit card, or any other payment method agreed upon between the RR Web Development and the Client.
- 2.2. The Client shall bear any transaction fees or charges imposed by the payment gateway or financial institutions in connection with the payment.

Late Payments:

- 3.1. In the event of delayed payment, the Client shall be liable to pay interest on the outstanding amount at the rate of **10% per month** or the maximum rate permitted by law, whichever is lower.
- 3.2. The RR Web Development reserves the right to suspend or terminate any ongoing web development services until all outstanding payments are received.

Taxes:

- 4.1. The Client shall be responsible for the payment of any applicable taxes, duties, or levies imposed by the relevant authorities on the web development services provided by the RR Web Development.
- 4.2. The RR Web Development's fees and charges do not include any taxes unless explicitly stated otherwise.

Refunds:

- 5.1. Refunds for web development services are subject to the RR Web Development's refund policy, as specified in the project proposal or agreement.
- 5.2. The RR Web Development reserves the right to withhold or deduct any costs or expenses incurred in providing the web development services from the refund amount, if applicable.

Disputes:

- 6.1. In the event of a dispute related to payments, the Client shall notify the RR Web Development in writing within **15 days of the payment due date**.
- 6.2. Both parties agree to make reasonable efforts to resolve any payment-related disputes through good-faith negotiations.

Confidentiality:



7.1. The RR Web Development shall treat all payment-related information and data provided by the Client as confidential and shall use it solely for the purpose of facilitating the payment transaction.

7.2. The Client acknowledges that the RR Web Development may engage third-party payment processors or financial institutions to process payments, and the Client's payment information may be shared with such parties to facilitate the transaction.

Limitation of Liability:

8.1. The RR Web Development shall not be liable for any damages, losses, or expenses arising from payment transactions unless caused by its gross negligence or willful misconduct.

Governing Law and Jurisdiction:

9.1. This Agreement shall be governed by and construed in accordance with the laws of South-West District, Dwarka Courts.

9.2. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of South-West District, Dwarka Courts

Entire Agreement:

10.1. This Agreement constitutes the entire understanding between the RR Web Development and the Client regarding payment transactions and supersedes any prior agreements or understandings, whether written or oral, relating to the same.
